UPDATE ON COLLEGE BUDGET – VICE PRESIDENT OF ADMINISTRATIVE SERVICES GERARDO RAMIREZ

Vice President Gerardo Ramirez provided an update on the college’s financial situation and ongoing efforts to improve transparency and communication. He began by expressing appreciation for the Senate’s continued commitment to supporting boards and clubs.

Moving forward, the goal is for Finance Director Moe Thanzin Cho to regularly present financial updates during Senate meetings. The administration is working to ensure greater transparency regarding how funds are being allocated and used. One way this is being accomplished is through public forums and committees. Budget forums are open to everyone, and the slides and recordings are available online under “budget form,” ensuring access to financial information for the campus community.

Vice President Ramirez also explained that in recent years, the college has experienced more expenses than revenue. As a result, funds have had to be drawn from savings to cover operational costs. Due to these financial challenges, some resources have been reduced.

Enrollment remains lower than desired, which has led to the need to compress certain classes. In making these decisions, the college is prioritizing courses that are required for graduation. Secondly, opportunities to consolidate classes are being evaluated. Third, consideration is being given to which student populations are being prioritized, full-time students as an example, acknowledging that these decisions directly impact students.

Questions and input are welcomed throughout the year. Members of the campus community may direct questions to Finance Director Cho or the financial committee. All related meetings are public, and dates and times are posted for those who wish to attend and stay informed.

FUNDING FOR KTPAMILY SOCIAL MIXER – KATIPUNAN

Motion to fund \$40 from the ICC/ Club Assistance (5031) account for flowers supplies for the KTFamily Social Mixer event first by Senator Dominguez and second by Senator Hong. Approximately 20 to 30 people are expected to attend. The event is planned to take place on February 12th, between 2:00 p.m. and 4:00 p.m. The motion carried with all members present voting in favor.

FUNDING TO ATTEND CA YOUNG DEMOCRATS NOMINATING CONVENTION – CSM DEMOCRATS

Motion to fund \$1523 from the ICC/ Club Assistance (5031) account for the California Young Democrats 2026 Endorsing Convention first by Senator Hong and second by Senator Jose. The convention will take place on February 20th and 22nd, this is the major event for young democrats in California for colleges, 4 club officers and 6 club members will be attending. The motion carried with all members present voting in favor, except Senator Lee, who abstained.

FUNDING FOR ART AND SCIENCE LECTURE RECEPTION – PROFESSOR MOHSEN JANATPOUR

Motion to fund \$700 from the College Program Assistance (5032) account for the Arts and Science Lecture Reception first by Senator Jose and second by Senator Lee. The event is planned to take place on March 20th, between 7:30 p.m. and 9:30 p.m. The motion carried with all members present voting in favor.

FUNDING FOR ASCSM WASHINGTON, DC ADVOCACY TRIP – ADVOCACY BOARD

Motion to fund \$16,000.00 from the Student Representation Trust for flowers supplies for ASCSM Washington, DC Advocacy Trip first by Senator Hong and second by Senator Jose. Senator Farzaneh and 5 advocacy members who were selected by an application and essay selection will attend. The trip date is still to be decided. The motion carried with all members present voting in favor.

FUNDING FOR PUBLIC RELATIONS MICS – PUBLIC RELATIONS BOARD

Motion to fund \$74.97 from the Publicity (5051) account for the Public Relations Mics first by Senator Dominguez and second by Senator Hong. After discussion, the funding was rounded up from \$74.97 to \$100. The motion carried with all members present voting in favor.
